What is the GIEN

- Network that take a lead role in promoting multi-stakeholder partnerships emphasizing government linkages and strengthen Girls and Inclusive Education .
- A group or system of interconnected people which considers special needs of women, girls, children with disabilities and marginalized groups to enable equitable learning opportunities.
- A network containing of girls, youth, and adult members as **representatives** from a range of stakeholders at the school, municipality, provincial, and federal levels.

Specific objectives

- Support communities to reduce harmful traditional practices such as early marriage and assist local governments and schools to re-enroll children into education
- Capacitate local education leaders enabling them to provide peer-to-peer guidance and mentoring to the most marginalized girls & Children with disabilities to address their wellbeing concerns.
- Strengthen commitment and capacity of schools for promoting gender responsive and inclusive education
- Influence and support government to ensure that the voices of marginalized children are prioritized on policy decisions and reflected in government action plans.

All Province & Some LGs have Committed to allocate budget for GIEN execution.

CEHRD is developing five years GIEN Strategic Plan in this fiscal year.

Formation of local level GIEN is completed for 189 municipalities among which 15 municipalities have endorsed GIEN procedures

Central & all provincial level GIEN have been formed and capacitated with 2 days Orientation.

Karnali, Bagmati & Gandaki Province are in progress to develop and endorse the GIEN guideline so far.

Achievement so far

Conducted two/ three days CRM Procedure training for 302 school's HT & Gender Focal person.

organized Joint monitoring /School Visit with the initiation of NGOs.

Conduction regular meeting & interaction at central, provincial and local level network.

More than 700 school-level CRM/GIEN Committee have been formed and preliminary training and orientations have been completed..

Planning, preparation and interaction to put forward GIEN intervention for upcoming years is ongoing in each provinces

**Achievement
so far**

Linkage with SESP

- Importance given to equity and inclusion. Included as a separate theme in section 5.3 as well as considered as a cross cutting agenda in every section of the plan.
- In outputs, key activities and targets section: 1.2.5 extend gender networks formed at province level to local level has been mentioned
- Further, In the program implementation manual of Nepal Government -MoEST 2022/2023, it is emphasized for expansion and strengthening of GIEN network. This will be continued in days to come inline with SESP.

Government plans for GIEN sustainability

- Finalize a five-year strategic plan to integrate and mobilize the scattered resources to achieve the goal of equity and inclusion in education.
- Develop ToR of GIEN.
- Expansion of GIEN to all Local Governments
- Develop capacity of GIEN at all level of government, so that they will lobby, advocate and support to provide quality inclusive education for marginalized children.
- Formulation of model GIEN procedure from the CEHRD level that can be adopted in local level as per local context/need which helps to bring and maintain the consistency in GIEN formulation and execution. (under discussion)

Government plans for GIEN sustainability

- Local level capacity building training for disability screening & materials support.
- Development of model directives for GIEN management
- Expansion and capacity building of GIEN in Province and remaining local level
- Training material development for the awareness of student abuse and bullying
- Model material development on multi language education.
- Embedding of equity index in IEMIS & Disability module development and strengthening in IEMIS

How other organizations can Get involved in GIEN

- Coordination and collaboration :- Strengthening Networking at all levels - Regular meeting, sharing good practices, Joint planning programmes and monitoring
- Capacity development:- Technical discussion in inclusive education
- Community of practice:- facilitation to “kick off” discussions, coordinate meeting logistics and ensure an appropriate collaborative atmosphere.
- Govt. encourage partners to plan and align GIEN into their existing and future programming.
- Resource sharing and joint planning for the scaleup of GIEN
